MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ [SAJ-2025-01678] [(MFR 1 of 1)]²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

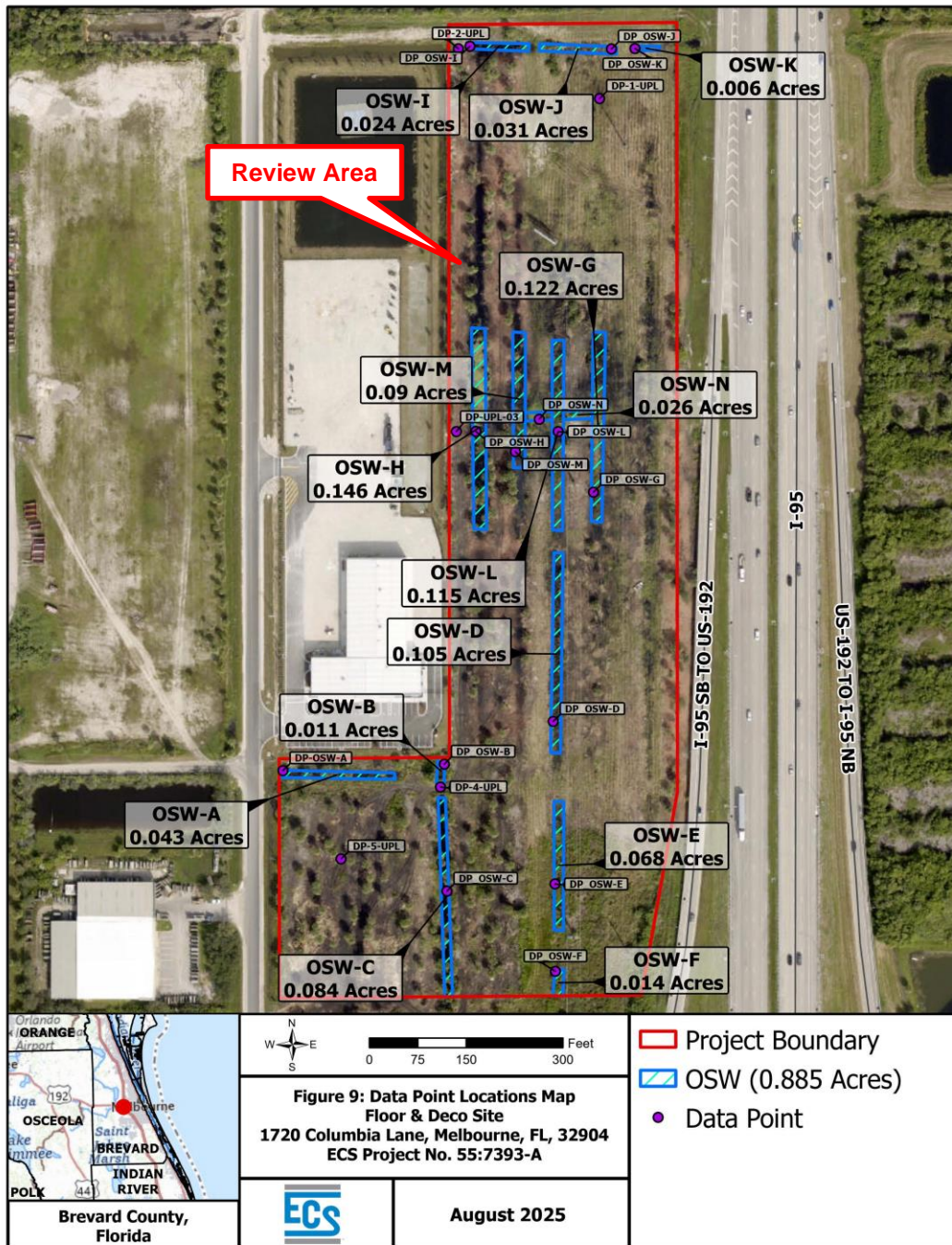

The above aquatic resources were not identified by the NWI or NHD. Land use within the review consists of predominantly abandoned tree crops and electrical power transmission lines. Soils we’re classified as hydric, except for the northeast and southeast corners of the review area. The authorized agent completed field investigations on 20 March, 22 May, 31 July, and 20 August 2025. Wetland determination and Ordinary High Water Mark (OHWM) forms we’re completed during the 20 August 2025 field investigation. An OHWM was present at each feature and no wetlands were identified for delineation. An OHWM was present at each feature and no wetlands were identified for

delineation. Precipitation (6.6 inches) at the time of the 20 August 2025 field investigation were representative of a normal wet season for this area, according to the Antecedent Precipitation Tool (APT). A boundary survey of the western adjacent property represented a culvert present along the northeast boundary and connected directly to OSW-I. The 20 August 2025 field investigation confirmed no direct hydrologic connection was present between OSW-I to the west ditch. Historical imagery (1951) provided by the agent identified that the features were excavated wholly in uplands for agricultural purposes. The subject features we're determined to be generally non-jurisdictional.

OSW-A, H, G, L, M, N:

The above aquatic resources were not identified by the NWI or NHD. Land use within the review consists of predominantly abandoned tree crops and electrical power transmission lines. Soils we're classified as hydric, except for the northeast and southeast corners of the review area. Historical imagery (1951) provided by the agent identified that the subject features drained an existing wetland for agricultural purposes. The authorized agent completed field investigations on 20 March, 22 May, 31 July, and 20 August 2025. Wetland determination and Ordinary High Water Mark (OHWM) forms we're completed during the 20 August 2025 field investigation. An OHWM was present at each feature and no wetlands were identified for delineation. Precipitation (6.6 inches) at the time of the 20 August 2025 field investigation were representative of a normal wet season for this area, according to the Antecedent Precipitation Tool (APT). A boundary survey of the western adjacent property represented a culvert present along the southeast boundary and connected directly to OSW-B. The 20 August 2025 field investigation confirmed that no direct hydrologic connection was present from OSW-B to the subject features. The features we're determined to be relatively permanent waters that do not have a continuous surface connection to a jurisdictional water and are therefore non-jurisdictional.
