MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ NWO-2025-00470-WEH (MFR 1 of 1)²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

Based on a review of all the years of available aerial imagery available through Google Earth, ESRI World Imagery Wayback, and Historic Aerials, Basin 1 has not previously possessed, nor does it presently possess, a continuous surface connection to a jurisdictional water. An evaluation of Basin 1 with the Antecedent Precipitation Tool (APT) showed water present in normal conditions. Water levels in the pond appear to change significantly depending on the season and drought conditions. However, review tools provide no indication of a connection to the Platte River (RPW), 0.42 miles away. Neither the National Wetlands Inventory Map nor the National Hydrography Dataset indicate the presence of wetlands or surface flow. Additionally, the 3D Elevation Program Digital Elevation Model shows a steep slope profile surrounding the pond, with no pathway for surface water flow. Basin 1 does not have a continuous surface connection with the Platte River (RPW), and therefore is non-jurisdictional under *Sackett*.
